## Conference Reports Show VFW is Making a Big Difference

Marking the halfway point of the 2016-17 program year, the Department's Mid-Winter Conference in Pittsburgh during late January showcased Pennsylvania VFW programs and services that impact many thousands of veterans, military personnel and citizens in the Commonwealth.

Department officers and committee chairpersons reported how Pennsylvania VFW award programs, scholarships, donations, community projects and special events support State Commander Thomas A. Brown's leadership theme, "You Make a Difference."

"The Pennsylvania VFW has a lot to be proud of, from the state and district levels down to our local posts," Commander Brown stated to 350 conference participants. "Your hard work and dedication to keep the VFW mission going strong is making life better for your fellow veterans, our troops and our neighbors."

Speaking on behalf of the VFW National Headquarters, the Department's National Council Member, Robert Eiler, also commended Pennsylvania VFW leaders and members for showing that "No One Does More for Veterans."

"I am so proud of the outstanding work being done by my comrades in our Department to support the VFW mission," said Eiler, who served as State Commander during 2005-06. "The good work you do is showing that the VFW is an active, effective organization worthy of support by veterans of all ages.

"We need to bring in more members, and they will want to join if we tell them how the VFW is helping them and so many others. We need to make sure that our good work is known by eligible members, military personnel, the media and our communities."

#### **Serving Veterans of All Ages**

During the 2015-16 year the Department's State Service Officers filed 5,736 claims for veterans, had 53,419 veteran contacts and brought \$44,595,471 of federal benefits to Pennsylvania veterans. This service helped veterans from World War II up through modern wars to improve their lives through healthcare services, compensation awards, pensions and other benefits.

Many VFW members volunteer their time to support Veterans Courts across the state. Department programs assist homeless and unemployed veterans, veterans impacted by diabetes and arthritis, veterans still in the

#### General Orders #3



- 1. ELIGIBILITY: The attention of the Post Commander is directed to Section 101, has amended July 25, 2016. The Investigating Committee should not recommend acceptance of an application unless eligibility has been fully determined. Post investigating committee should approve/disapprove each applicant.
- 2. MEMBERS IN GOOD STANDING: Commanders on all levels will enforce the provisions of Section 105 of the National By-Laws (as amended July 25, 2016, effective August 26, 2016) and Manual of Procedure. A member whose dues are unpaid after their anniversary date ceases to be a member in good standing and loses all rights of membership in the VFW.
- 3. DELINQUENT DUES COMMITTEE: All Post Commanders are directed to appoint a Delinquent Dues Committee for the purpose of contacting and collecting dues from delinquent members. The Committee should start operating NOW by visitation at the residence of delinquent members and collect their dues. Personal contact will bring results.
- 4. TRUSTEES REPORT OF AUDIT: Attention of Post Commanders is directed to Section 218 of the Manual of Procedure - Duty of Trustees: Trustee Report of Audit must be completed by the Trustees in detail, at the close of each quarter, one of which will end March 31, 2017. Commanders are reminded that all funds are to be under the custody and control of the Post Quartermaster. Persons other than the Post Quartermaster, who may handle post funds, such as Club Manager, Bingo Chairman, or Committee Chairman are responsible to the Quartermaster to maintain accurate records and accounts and should be properly bonded. Post Trustees are to ensure that the financial records of these special funds are also audited in the same manner as other accounts of the Post Quartermaster.
- 5. NOMINATION, ELECTION, INSTALLATION OF POST OFFICERS: Section 217 of the National Manual of Procedure states: Post officers shall be nominated in March and elected in April. A member making the nomination of an absentee for any office shall have presented to the Adjutant, in writing, the consent of the member being nominated prior to the opening of nominations. Post officers shall be installed in their respective offices prior to the convening of the Department Convention, but shall not assume their duties until the Department Commander is installed. An officer-elect who may be absent for a good and sufficient reason or cause may be installed, at any regular or special meeting prior to the Department Convention, if not then installed, the office will automatically become vacant.

THE POST MUST SEND IN THEIR ELECTION REPORT IMMEDIATELY AFTER THE ELEC-TION IN APRIL TO DEPARTMENT HEADQUARTERS AND NATIONAL HEADQUARTERS.

#### **VA Lejeune Presumptive List & Choice Program Updates**

regulations to establish presumptions for the service connection of eight diseases Review, whichever is later. associated with exposure to contaminants in the water supply at Camp Lejeune, N.C.

The presumption of service connection applies to active duty, reserve and National Guard members who served at Camp Lejeune for a minimum of 30 days (cumulative) between August 1, 1953 and December 31, 1987, and are diagnosed with any of the following conditions: adult leukemia; aplastic anemia and other myelodysplastic syndromes; bladder cancer; kidney cancer; liver cancer; multiple myeloma; non-Hodgkin's lymphoma; and Parkinson's disease.

Environmental health experts in VA's Technical Workgroup conducted comprehensive reviews of scientific evidence, which included analysis and research done by the Department of Health and Human Service's Agency for Toxic Substances and Disease Registry (ATSDR), the Environmental Protection Agency, the International Agency for Research on Cancer, the National Toxicology Program and the National Academies of Science.

Veterans with 30 or more cumulative days of active duty at Camp Lejeune during the contamination period are already eligible for certain benefits, following passage of the Honoring America's Veterans and Caring for Camp Lejeune Families Act.

In the early 1980s, volatile organic compounds, trichloroethylene, a metal degreaser and perchloroethylene, a dry

cleaning agent, as well as benzene and vinyl chloride, were discovered in two on-base water supply systems. Those contaminated wells were shut down in February 1985.

The area included in this presumption is all of Camp Lejeune and MCAS New River, including satellite camps and housing areas. The rule will be effective either

#### **VA Choice Program**

VA appreciates the Office of Inspector General (OIG) review of VA's implementation of the Veterans Choice Program (VCP). The OIG report reviewed the VCP from its inception in November of 2014 through September of 2015. Overall, the Department concurs with the findings in the report. However, VA noted that VCP is no longer the program it was when rolled out and significant improvements have been implemented.

VA notes that it did not wait for the OIG report to publish before taking critical steps towards improving the program, including working with Congress to amend the law four times to increase access and satisfaction with VCP, including growing the provider base, increasing scheduled appointments and implementing process changes.

#### **ELDERLY VETERANS**

According to the 2012 U.S. Census brief, veterans age 65 or older numbered in excess of 12.4 million. These veterans served in conflicts around the world including World War II, the Korean War, the Vietnam War, and even in the Persian Gulf War. As veterans age, the VA will provide benefits and services that address a variety of issues including the changing health risks they face, as well as financial challenges through VA benefits and health services.

Elderly veterans may be eligible for a wide variety of benefits available to all U.S. military veterans. VA benefits include disability compensation, pension, education and training, health care, home loans, insurance, vocational rehabilitation and employment, and burial assistance.

Two VA programs provide certain elderly veterans with an additional monetary amount if you are eligible for or receiving a VA Pension benefit:

AID AND ATTENDANCE (A&A) is an increased monthly pension paid if you meet one of the conditions below-

- You require help performing daily functions, which may include bathing, eating or dressing.
- You are bedridden.
- You are a patient in a nursing home.
- Your eyesight is limited to a corrected 5/200 visual acuity or less in both eyes; or concentric contraction of the visual field to 5 degrees or less.

HOUSEBOUND is an increased monthly pension amount paid if you are substantially confined to your immediate premises because of a permanent disability.

military through Unmet Needs, Operation Uplink and Adopt-a-Unit programs.

The Department continues visiting VA medical sites in the state to discuss healthcare issues with staff and interview veterans to ensure their needs are met.

The VFW is actively engaged with student veterans by providing support on campus, at local posts and through several partnership programs.

Protecting veterans' rights remains a top priority, as evidenced through conference reports about VFW advocacy at the state and national levels. VFW staff is frequently consulted by lawmakers about key issues facing veterans, which often leads to the VFW giving testimony during legislative hearings in Harrisburg and Washington, D.C.



#### By-Laws Establish Election and Installation Rules

Post officers, elected and appointed, shall submit proof of eligibility to the post adjutant. Post officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Such proof of eligibility shall be open to and reviewed by the commander, adjutant and quartermaster prior to the installation of office. If an elected or appointed officer does not prove eligibility within 60 days of election or appointment, the right of the officer to hold office shall be forfeited and the office vacated. Section 217 of the National By-Laws refers to the Manual of Procedure for details on installing officers immediately after elections. - 7. LOYALTY DAY: Posts are urged to start planning NOW for Loyalty Day observances in their community. Requests for LD materials should be forwarded to National HQs to the attention of the Americanism Department. Loyalty Day Poster Contest, "I pledge allegiance", deadline for entries was March 1, 2017. The State Loyalty Day Program: State Capitol, May 1, 10:00 a.m.
- 8. MEMORIAL DAY BUDDY POPPY CAMPAIGN: Commanders on all levels should begin organizing their 2017 Memorial Day Poppy distribution to raise donations for the Post Relief Fund. Every Post is required to order and distribute Poppies. Order Now! There are several Buddy Poppy contests a listing can be found at www.vfwpahq.org. Remember our motto "NO ONE DOES MORE FOR VETERANS."
- 9. ARREARAGE: Any Post in arrears for National, Dept., County Council or District dues, Poppy monies, supply monies or other financial obligations, or failing to have the Quartermaster properly bonded, or failing to submit properly completed quarterly Post Trustees Report of Audit or Post Election Report shall be deprived of all representation in County Council meetings, District, Dept. and National Conventions. Representation will be restored upon proper adjustment of such deficiencies.
- 10. DEPARTMENT CONVENTION RESOLUTIONS: Dept. Committees will meet at 9:00 p.m., Wed., June 14, 2017 to approve/disapprove resolutions for consideration at the 2017 State Convention. All delegates are encouraged to attend Committee Meetings to become more knowledgeable of pending resolutions. Committee reports will begin on Thursday, June 16th during General Session.
- 11. INTERNAL REVENUE SERVICE FORM 990: Post Commanders should ensure that information returns are filed annually on Form 990. These forms may be obtained by calling Federal Tax Forms & Publications hot-line (800) 829-3676. The forms must be filed on or before the 15th of the fifth month following the close of the respective annual accounting period. If gross receipts are \$50,000 or less you need to file e-postcard 990N online, the IRS asks ONLY the heading on page one be completed, being sure to check Box B and send it to the Ogden IRS Center, Ogden, Utah 84201.
- 12: STATE CONVENTION: The Department's State Conv. will be June 14-17, 2017 at the Doubletree, 500 Mansfield Ave., Pittsburgh, PA 15205. 412-920-8050. See www.vfwpahq.org
- 13. NATIONAL CONVENTION: The Veterans of Foreign Wars 118th National Convention will be held in New Orleans, LA, July 22-26, 2017.
- 14. Attention of Post Commanders is directed to Section 222 of the National By-Laws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten-dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out this month. Registration forms for the 118th National Convention should be mailed to: Convention Registration, 406 West 34th Street, Kansas City, MO 64111.
- 15. DIVERSITY: The Dept. of PA, VFW of the U.S., shall not restrict or restrain from holding any elected or appointed office or position within the Dept. of PA any member in good standing thereof based solely upon the individual's age, gender, race, ethnic or sexual preference, physical impairment or disability, or any similar categorization of a prejudicial or discriminatory nature: nor shall any such restriction or restraint by any Post, District, County Council or other organizational division of this Dept. be tolerated. Dept. of PA, VFW, reminds all duly elected Chaplains at all levels within this Dept. to adhere to those references to a supreme being as set forth in the VFW Ritual during all official functions of this organization, not to interject reference to any specific deity or deification during same.
- 16. CAPS: Only regulation caps can be worn at meetings/conventions or special occasions.

#### Hospice Care Companies and Veterans: A Chaplain's Guide to Making Wise Decisions

Hospice care is a great thing. And as hospice care has developed, it has become big business-in 2014 it was a \$17 billion industry. Endof-life care is needed, and those in the business provide a valuable

As hospice care companies developed and competition grew,

they realized there was a niche market-older veteranswho became easy targets as hospice companies sought business. Using marketing techniques including professional brochures, these companies sought to expand their business. These "for profit" companies specifically started targeting veterans.

I believe the majority of hospice companies provide a good service and are operating in good faith. While targeting and wanting to care for veterans is not necessarily a bad thing, you need to be informed consumers.

Representatives from two hospice companies have contacted me. They would love to have my endorsement and, ultimately, the VFW's endorsement. VFW Chaplains and Commanders across our nation no doubt will also be contacted as hospice companies seek potential clients.

In an effort to get the word out to veterans and their families, a representative from a particular hospice company may contact VFW Commanders and Chaplains and ask to make a presentation at Department, District, and/or Post meetings, or to have literature distributed about their services to veterans.

Here is an email I received: "Hello Peter, Just wanted to touch base with you to let you know I've already met with \_\_\_\_ District \_\_\_ Commander, \_\_\_ County. I spoke at their District Mtg this month briefly about \_\_\_ Hospice and Honor Flight. I'm still trying to touch base with other VFWs, and in the meantime, will be meeting with a Marine Corps League. I think meeting with Chaplains would be very beneficial and would like to discuss this with you. When would be a good time? Thanks."

I have not and will not endorse any hospice company. And, I would caution you about having any hospice company make a presentation at one of your

meetings. From my research and personal conversations, I have made the following observations:

- The hospice companies that are targeting veterans do not provide anything more, with regard to hospice care for veterans, than other hospice companies.
- The sales pitch of hospice companies targeting veterans is designed to leave the consumer with the impression that they are in business to honor and care for veterans. Remember, these are for profit companies that exist to make a profit.
- I am not sure there is any significant savings from using these companies. Just because they "honor veterans" doesn't mean there is a cost benefit.
- · Providing information on VA Benefits can and should be done by one of our VFW certified Service Officers. There is no benefit by getting the information through a hospice company.

When families hear that a company services and caters to veterans, they can think that they may get a discount or some special care. This may or may not be true. Shop around and compare services and costs.

Barbara Muntz, a senior advisor with Community Health Accreditation Program, and an experienced home care and hospice nurse, wrote the following instructions to her children about selecting hospice care for her, when the time comes. I have found this helpful in guiding families in knowing what to look for, questions to ask, and things to consider:

Are you accredited by a nationally recognized accrediting organization? Accreditation is not a guarantee, but hospices that seek accreditation are inspected more thoroughly, and usually more often, than those that do not.

How long have you maintained your accreditation? Hospices that have maintained their standing through multiple cycles of accreditation show that they have sustained the kind of quality needed to provide a high level of care. Many hospices go through one accreditation survey, then do not maintain the requirements. Look for a hospice that has been through at least two three-year cycles of accreditation, or better, three or more cycles.

What has your average daily census been for the last 12 months? You would never have brain surgery at a hospital that only does five brain surgeries a year, right? Of course not – you would go to a hospital that does a ton of brain surgeries and does them well. The same principle applies to hospice. The more patients with my diagnoses that a hospice has seen in the last year, the more likely it is that the team has the expertise to provide better symptom management and care.

How do you manage care after hours? The hospice should explain that they have a nurse on call and hospice team members can come to assist 24/7. Ask them for their after-hours call number. Then call it in the evening (Saturday nights are always good for this!) to see how long it takes to get a return call.

What is your model for providing continuous care? Sometimes things get rough, and the patient may need round-the-clock care for a few days to manage symptoms or give the family a break. Every hospice must provide this care, if needed. Ask if they have a "prn" pool or their own private duty staff when needed. Ask them to give you their average time to staff a continuous care case.

Hopefully, this guidance will help families in choosing hospice care. Feel free to contact me.

held in April. Section 217 describes the choices of how to elect whether you use a poll system or open or written ballot. The eligibility for office is covered in Section 215 of the Bylaws and Section 216 covers elected and appointed officers.

If you follow these three sections when conducting nominations and elections you can't go wrong. You also need to remember that Section 218 describes the duties of each office so all leaders should know their responsibilities.

When your post elections are over in April, please don't wait until May, when most officers are installed, to send in your election report. Submit your report as soon as your election process is completed to ensure that your report is
